**SUBJECT: Issues Update**

The following are issues related to the City for the weekly Issues Update. If there are additional items you believe should be included, please let me know.

**Communications Specialist Selection**

The City of Peoria is pleased to announce the selection of Stacy Peterson to serve as its Communications Specialist. Earlier this year the City Council approved the addition of a position within the City Manager’s Office that will coordinate efforts to keep citizens and businesses informed about critical City services, events and news.

Stacy was chosen from a pool of over 100 candidates. Her strong written and verbal communication skills, knowledge of the community and passion for Peoria were all factors in the selection. For the past three years, she has worked in the Programming Department of the Peoria Public Library, coordinating programs, projects, musical performances and exhibits. In this capacity, Stacy worked with patrons to identify needs and to develop and implement programs that address these needs. Prior to working at the Library, Stacy coordinated special events for the Peoria Art Guild, including organizing the annual Fine Art Fair on Peoria’s Riverfront. Stacy has a bachelor’s degree in English from the University of Iowa and a master’s degree in communications from Western Illinois University.

The position is responsible for coordinating both internal and external communications. This will include overseeing the content on the City’s website, managing the City’s social media presence, coordinating news stories with traditional media outlets, and developing public information programs.

Stacy starts Monday, November 10<sup>th</sup>.

**Fire Prevention Week Activities**

The Fire Department held numerous activities throughout fire prevention week, which took place from October 5<sup>th</sup> through October 11<sup>th</sup>. The activities are outlined below.

- Conducted a joint smoke detector campaign with the American Red Cross and West Central Bluff Neighborhood Association in which the combined effort resulted in canvassing 147 homes; of those 147 residences, the Department was able to visit with 32 households. The Department installed 38 smoke alarms in 22 homes, replaced 5

batteries in 3 homes, provided fire prevention and preparedness education to 25 households, provided tornado prevention and preparedness education to 29 households, and assisted 19 households with the development of their home fire escape plan.

- Conducted 12 tours at five different fire stations resulting in 282 visitors.
- Recognized 5 Jaimeson School students as honorary Fire Chief for the day for their successful effort in the Peoria Fire Department annual Jamieson School poster contest.
- Conducted 3 evacuation drills at Bradley University resident halls, dorms and apartments.
- Conducted a business evacuation training and informational exchange session with the Advanced Correctional Healthcare group.

### **Self-Defense Training for Field Personnel**

Police Department personnel provided self-defense training to thirteen field personnel from the Community Development Department this week. The training covered basic techniques that could be used by personnel who find themselves in potentially dangerous situations. The Community Development Staff that attended the training consisted of Building Inspectors, Code Enforcement Inspectors and Urban Planners. All of these City employees are regularly in positions where they are making solo field inspections. The Community Development Department appreciates the support and training provided by the Police Department.
