City of Peoria Fireworks Update

FOR IMMEDIATE RELEASE:

Peoria (07/2/15)—The UnityPoint Health - Methodist | Proctor Red White and Boom 4th of July activities are scheduled to begin at 5:00 p.m. this Saturday on the Peoria Riverfront. The fireworks show is scheduled to begin at approximately 9:30 p.m. This year, Water Street will be closed to vehicles to allow viewing for pedestrians. To protect the reinforced barrier wall, the public will have limited access to the riverfront near the water. Peoria Police request that the public keep riverfront bike/walk path open to pedestrians. The public is invited to bring their chairs and view the fireworks from Water Street. Please see the attached map for details.

The Peoria Jaycee's Firecracker 5000 will be held in downtown Peoria on Saturday morning. Expect partial lane closures from 7:30 a.m. - 9:00 a.m. on Washington and Adams Streets. Please be aware of participants and allow for extra time to travel in the area during this time.

Some important changes to note in regards to Saturday's events:

- Water Street from State to Eaton will be closed to vehicles starting at 9 a.m. There will be no public parking available along Water Street or in Riverfront parking lots. Handicapped parking will be available on Water Street, from Hamilton to Eaton.
- Barricades will be set up on Washington Street at the following intersections: Hamilton, Main, Liberty, Harrison & Walnut.
- The Bob Michel Bridge will close at 9:15 and reopen at approximately 10:45 p.m.
- Parking is free in the Jefferson and Niagara decks on a first come, first serve basis. Paid parking may be available in private lots and decks.

There will be ample space on Water Street to view the fireworks. There will be limited access to the Riverfront Village deck. Businesses on the deck are open and accepting reservations for outdoor dining.

Upon conclusion of the fireworks, Peoria Police will first allow pedestrians to exit the riverfront area. The police will then gradually allow car traffic. Please plan about one hour of time following the conclusion of the fireworks to exit the downtown area.

The regularly scheduled Peoria RiverFront Market will be located in the Marquee parking lot of the Peoria Civic Center, located at the corner of Kumpf Boulevard and Jefferson Streets. Hours for the market are 8 a.m.-noon and free parking will be available in the PNC deck during the hours of the market. Cars may be towed after 1 p.m.
