**ShotSpotter Expansion**

The ShotSpotter three square mile expansion has been officially completed. The Police Department has been working in conjunction with ShotSpotter to implement this project for several months. A validation test was conducted by Peoria Police Range Officers on the night of Wednesday, May 20<sup>th</sup>, in the coverage area. The validation test was 100% successful. The ShotSpotter expansion was fully operational and in use as of 3:00 PM Thursday, May 21<sup>st</sup>. The near North End and East Bluff neighborhoods are now being monitored by ShotSpotter technology.
