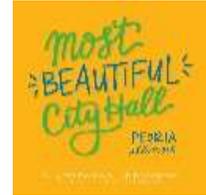

**SUBJECT:** Issues Update

The following are issues related to the City for the weekly Issues Update. If there are additional items you believe should be included, please let me know.

**Public Works—Seal Coating on City of Peoria Streets**

On Friday August 3, 2018, work will begin on the city's **2018 Seal-Coating Project**. **No Parking** signs have been placed on streets that will be affected and will remain in place until the work has been completed and the contractor moves to the next location. The seal coating will be completed within approximately one week, weather permitting. These treatments will extend the life of roadway pavement. Residents are asked to be patient and travel with caution in these areas.

The work will consist of street sweeping, seal coating, and an additional clean-up street sweeping a few weeks after the work has been completed. The work will be performed on one side of the road at a time, and each side of the road will be closed for a few hours while the seal-coat cures. Please note: additional clean-up sweeping will take place a few weeks after the seal coating has been completed, so some loose rock will remain until that time.

Neighborhoods will be notified with a letter 24 to 48 hours in advance of the work in their areas. When notified, residents will be asked to remove all vehicles from the designated **No Parking** area until the project has been completed and the **No Parking** signs have been removed. Access to driveways are typically blocked for only 10-20 minutes. Emergency vehicles will have access at all times.

### **Chicago Shakespeare in the Parks Comes to Peoria—August 18 and 19**



Chicago Shakespeare Theater announces free Chicago Shakespeare in the Parks tour performances in Peoria, Illinois to celebrate the 2018 Illinois Bicentennial. This year's tour marks the first time the program has traveled outside of Chicago in its seven-year history. This summer, the Tony Award-winning Theater's founder and artistic director Barbara Gaines stages her new music-filled adaptation of Shakespeare's timeless classic *A Midsummer Night's Dream*.

The Peoria performances of *A Midsummer Night's Dream* will be presented in Glen Oak Park (2218 N. Prospect Rd.) on Saturday, August 18 at 7:00 p.m. and Sunday, August 19 at 2:00 p.m. A specially equipped truck will travel downstate and unfold into a stage—and a company of professional actors will share Shakespeare's magical comedy with neighbors of all ages.

Marking the 200<sup>th</sup> anniversary of statehood, the Illinois Bicentennial is a yearlong, state-wide celebration honoring the cultural, economic, academic, and political contributions that Illinois has made to the nation and the world.

In addition to the Peoria performances, Chicago Shakespeare in the Parks will bring free world-class performances to 18 neighborhood parks throughout Chicago, July 25–August 26, 2018.

Duplicating its successful community engagement efforts piloted in Chicago over the first seven seasons of the program (as part of Mayor Rahm Emanuel's Night Out in the Parks Initiative), the Theater will work in partnership with the Peoria Park District—the oldest and largest park district in Illinois—as well as residents and community organizations to cultivate new audiences from neighborhoods across the down state region.

### **Peoria Public Schools – Update from Superintendent Dr. Sharon Desmoulin-Kherat**

It takes a remarkable team to teach our remarkable Peoria Public School students, and recently our team has grown to include nearly 70 new teachers. These fresh faces have come to us from far and wide, and they are spending time at our Administration Building for New Teacher Week.

This week is full of instruction and conversations on a variety of topics – from basic logistics and foundations for effective teaching, to social-emotional learning and instructional resources and tools. I had the chance to speak with this group on Monday; I hope I conveyed my own enthusiasm for the work we do, and maybe even provided some motivation and inspiration. This week is a wonderful first step on these teachers' careers with Peoria Public Schools. They have the chance to connect with each other while getting acclimated to our PPS culture. I believe that when our teachers succeed, our students succeed. When our teachers feel supported, they are better positioned to support our students. That's what this week is all about.

At this time, we are about 95 percent staffed for the 2018-2019 school year. We are still hiring certified teachers; in fact, we hope to find another 45 to join our ranks. We also need about 15 special education teachers, which is a difficult skill set to find. In addition to certified staff, we have a number of other positions available, including bus drivers and monitors. Our first day of school is quickly approaching. Our new teachers are excited, and so am I. I can't wait to see all of our students walk through the doors on August 15. We'll have shortened days until after Labor Day, with each school dismissing one hour early for the first two weeks. This is one of our busiest times of the year, but I wouldn't have it any other way.
