*Each year the City Council makes spending decisions on critical services like public safety, infrastructure, and the quality of life in Peoria's neighborhoods. They also determine how to pay for it. The City is required to balance its budget annually, and the City Council has made a number of tough decisions in order to live within our means.*

*Since 2014, the City population has declined, and revenues have as well. To balance the budget, the City has reduced services, trimmed the workforce, and raised new revenues.*

*The current challenge before the City Council is a \$2.0 million budget deficit for 2020.*

*This year, the City has two online platforms to provide input for the budget process.*

As an educator and a one-time soccer-parent, I have observed how enormously valuable participating in athletics can be to young students. Participating in sports gives young students a way to develop social skills, teamwork, communication skills and cooperation. Practicing to master skills teaches self-discipline and boosts self-confidence.

And since we’re on the topic of athletics, our fall sports schedule is already underway. On the high school level, boys football, soccer and golf; girls swimming, volleyball and tennis, and co-ed cross country teams are competing almost every day. (Peoria, IL) - Friday, August 30, 2019, Shazam racing will hold the 2<sup>nd</sup> annual Peoria Beer Mile event in downtown Peoria. The runners for this event will run a quarter mile loop that's barricaded off in the alleyway of Commercial Street, Walnut Street and Water Street between the intersection of Walnut and the Bob Michael Bridge.
