CITY ORDINANCE ALLOWS A SUPPLEMENTAL LICENSE TO BE OBTAINED BY A LICENSEE CURRENTLY HOLDING A VALID CLASS "C" (GROCERY) LICENSE ISSUED UNDER CHAPTER 3 OF THE CODE IN WHICH THE SQUARE FOOTAGE OF THE BUILDING OF THE ESTABLISHED ESTABLISHMENT IS AT LEAST 50,000 SQUARE FEET AND MEETS THE DEFINITION OF A SUPERMARKET GROCERY STORE AS DEFINED IN SECTION 3-1 OF THIS CHAPTER, AUTHORIZING THE RETAIL SALE OF ALCOHOLIC BEVERAGES FOR ON-SITE CONSUMPTION AS PART OF A FULL SERVICE RESTAURANT, WITH WAIT STAFF, THAT SERVES PREPARED MEALS WHICH EXCLUDES THE SERVING OF SNACKS AS THE PRIMARY MEAL ONLY IN AN AREA DESIGNATED AND OPERATED AS A RESTAURANT AS DEFINED IN SECTION 3-1 UPON APPROVAL WITH THE FOLLOWING REQUIREMENTS:

Supermarket grocery store means a large form of the traditional grocery store, offering a wide variety of food and household products, but is smaller and more limited in the range of merchandise than a hypermarket or big-box market which sells grocery, but carries a wider range of items such as clothing, equipment, electronics, furniture, household cleaning appliances or machines such as vacuums, and other items traditionally sold in a department store.

Nothing in this subsection shall be construed to authorize a Class C licensee with a subclass 12 supplemental license to qualify for subclasses that are available only to Class "B" (restaurant) license holders.
