The Light 2021 conference, hosted by the Center for Prevention of Abuse, brought together professionals from many different fields from US, Canada, and Ireland to share best practices, technology, preventative efforts, and survivor care strategies to help prevent, combat, and respond to the human trafficking crisis. Speakers included trafficking survivors, authors, advocates, attorneys, doctors, and trafficking experts.

Community Development-City of Peoria Utility Assistance Program Lottery Held Wednesday, May 19th

The application period for the city of Peoria's Utility Assistance Program is now CLOSED. A virtual lottery was held on Wednesday, May 19th at 10:00 AM. Selected applicants are being contacted by City staff, and a list of selected applicants as well as a recording of the lottery can be found at www.appreciatepeoria.com.

The Utility Assistance Program will provide utility bill relief to households impacted by the COVID-19 pandemic. A total of \$300,000 has been dedicated to the Utility Assistance Program, providing up to six consecutive months of payments for delinquent electric, gas, or water bills to approved applicants.

The Utility Assistance Program, made possible through the federal CARES Act that awarded the city of Peoria with funding in Community Development Block Grant Coronavirus (CDBG-CV) funding to assist our community's response to COVID-19. The Utility Assistance Program helps keep residents in their homes and prevent homelessness.
