

City Manager's Office—City of Peoria Seeks Community Input on Coronavirus Relief Funding



The city of Peoria has been awarded \$47,089,976 in Coronavirus State and Local Fiscal Recovery Funds. The City Council voted in June to use \$10,301,585 of the FRF to eliminate the need to issue working cash bonds in 2021 and to curtail furloughs for affected non-union employees.

The amount of \$36,788,391 remains to be obligated by December 31, 2024. The City is reaching out to residents to give their spending priorities for the remaining funds. The survey, found on

www.peoriagov.org/engagepeoria, is comprised of 4 questions that ask to rank the order of priorities. There is also an option to weigh in on the biggest impact to our community due to COVID-19. Residents may email additional comments to engagepeoria@peoriagov.org. The survey will be open until 5:00 pm on August 19. Paper copies of the survey can be found at all [Peoria Public Library locations](#).

The survey will allow residents to have input into the decision-making process of the City Council. City leadership will review community input and prioritize the ideas and suggestions into issues. City Departments will submit proposed programs and projects to address COVID-19-related issues. Projects and programs will be proposed for funding to the City Council based upon the community priorities.

Community Development-2022 Community Development Block Grant

The application period for 2022 Community Development Block Grant (CDBG) Public Services funding will open at 8:00 AM on Monday, July 26th and close at 3:00 PM on Friday, September 3rd. This funding is available to not-for-profits, 501(c)3 organizations, and government agencies to provide services to low- and moderate-income persons. Eligible applications will be reviewed by the CDBG Public Services Advisory Commission, and agencies will be notified of funding decisions following City Council approval.

The city of Peoria receives CDBG funding each year from the U.S. Department of Housing and Urban Development (HUD). Up to 15% of the annual funding amount can be used to fund public service programs serving low- and moderate-income persons.

Interested organizations are encouraged to attend a virtual application training session. City staff will offer the virtual application training sessions at two different times: Tuesday, July 27th at 2:00 PM and Thursday, July 29th at 10:00 AM. PPS Wraparound Center presents workshop detailing free legal services funded by R3 grant

Peoria Public Schools Wraparound Center will present a free legal workshop, Saturday, July 24, 10 a.m. to noon at The Wraparound Center, 1419 S. Folkers Ave., Door No. 16.

State Rep. Jehan Gordon Booth and Attorney Yolanda Riley will share information about the legal services funded by the State of Illinois Restore, Reinvest, Renew (R3) grant. Through the R3 grant, residents who qualify can receive free legal representation in family law, expungement and sealing of criminal records, orders of protection and landlord/tenant negotiations.

Wraparound Center Director Derrick Booth also will share information about other resources provided by the center's partners including:

- Trauma recovery counseling
- Substance abuse counseling
- Behavioral health services
- Support for single parents
- Support services for juveniles in the justice system
- Food pantry
- Respite for suspended students
