

City of Peoria Offers Warming Centers

With plummeting temperatures forecasted for the upcoming week, the City wants to remind residents that the Peoria Police and Peoria Fire Departments have options for warming centers.

The Peoria Police Department lobby, 600 SW Adams Street, normally closed to the public from 5:00 pm to 9:00 am, will remain a warming center, regardless of the time of day.

All Peoria Fire Department Fire Stations are open to the public until 10:00 pm, but persons seeking help or heat can go to any Fire Station at any time. It's important to note that if the crew

is sent on a call, any persons using the station as a warming center will have to temporarily leave during that time. Locations of Fire Stations may be found on the City's website <http://www.peoriagov.org/fire-department/>

Any visitors to City buildings will have their temperatures checked and be required to wear a mask, per the City's COVID-19 policy to protect staff and visitors.

Applicants must meet all eligibility requirements, including owning the home for at least one year, passing an interior and exterior inspection, and having active homeowners insurance.

Peoria Fire Department—Keep the Wreath Red Results for December 2021

On December 1st, 2021 the Peoria Fire Department launched its annual “Keep the Wreath Red Holiday Campaign.” The campaign is designed to encourage citizens to practice fire safety at home and workplace during the holiday season. The program concluded January 1st, 2022 with the following results:

- 15 structure-fire related incidents; this is one less incident than what occurred in 2020
- 10 working fires (extensive fire capable of doing considerable damage)
- 4 civilian injuries due to structure fires are included in 2021 which is a decrease from 6 civilian injuries reported in 2020
- Estimated property damage of **\$781,200** up from the 2020 estimated property damage amount of \$368,750

Peoria Public Schools – Update from Superintendent Dr. Sharon Desmoulin-Kherat

In the weeks since the Peoria Public Schools winter break began, an unprecedented surge in COVID-19 cases both locally and nationally has occurred due to the emergence of the omicron variant. To prepare for continued in-person learning in the face of this new variant, the Peoria Public Schools winter break for students was extended through Jan. 7.

Middle school athletics and activities will not be held this week. All scheduled high school athletics events will continue to be held this week. Restricted spectator guidelines will be communicated by each high school.

Friday, January 7 will be a Teacher Institute Day for school staff members. All PPS students, except Valeska Hinton Early Childhood Education Center (VHECEC) will return to school as normal on Monday, Jan. 10. VHECEC students will return to school on Tuesday, Jan. 11. These days will be made up at the end of the 2021-2022 school year.

PPS staff members are distributing to-go breakfasts and lunches this week for PPS students and their families. To-go meals are available from 10 a.m. to 1:30 p.m. Tuesday, Jan. 4 through Friday, Jan. 7. Below are the schools that will serve as food distribution sites this week:

- Harrison Community Learning Center
- Lincoln K-8 School
- Mark Bills Middle School
- Dr. Maude A. Sanders Primary School
- Roosevelt Magnet School
- Sterling Middle School
- Hines Primary School
- Manual High School, at the entrance facing Russell Field.
- Peoria High School, at the atrium entrance.
- Richwoods High School, at the front entrance.

The district offered Peace of Mind COVID-19 testing to staff members on Tuesday and Thursday this week. Staff members exhibiting COVID-19-like symptoms could be tested at the Peoria Civic Center or through their primary care physician. The Civic Center testing is offered from 8 a.m. to 4 p.m. Monday through Saturday.

Finally, we encourage all Peoria Public Schools students and staff, as well as their families, to consider using this week to receive the COVID-19 vaccine if you have not already. The Peoria County Health Department is administering the vaccine from 8:30 a.m. to 4 p.m. Monday through Friday and Saturday and Sunday from 9-5. No appointments are necessary.

1. Summary Information

- **One Stop Shop** is held every Monday at 1:30 PM in City Hall. This is a free service for anyone who wants to discuss development with staff from various City departments, local utility companies, the Health Department, and CityLink.
- **Development Center Permits** can typically be issued immediately and/or do not require an extensive review period. These permits include most trade (electrical, plumbing, HVAC, etc.) permits, repair permits, new single-family residential construction, alteration/additions, and demolitions.
- Each permit application includes a self-reported value of the project. The **Total Value of Development (YTD)** is the sum of these reported values.

2. Development Review Board Projects

- The **Development Review Board** is a group of City staff, local utility representatives, and other local government agencies that review and comment on more complex development applications and cases that are required to go to a public hearing.
- A **Job** is a development application that requires multiple departments to review for compliance but does not require a public hearing or City Council review.
- A **Project** is a development application that requires multiple departments to review for compliance and requires a public hearing before a City Commission and in some cases, a final decision by the City Council.
- The **Staff Assigned** to each Job or Project is the primary contact person for any inquires.
