St. Patrick's Day Route Information for Friday, March 17, 2023

The St. Patrick Society of Peoria will hold its annual parade on Friday, March 17, 2023, beginning



at 11:00 AM on Monroe at William Kumpf. The parade will travel northeast on Monroe to Main, right on Main to Jefferson, Jefferson to Liberty, Liberty to Adams, then conclude at Adams and Hamilton where vehicles and floats belonging to participants will disembark.

Parking is prohibited along the parade route. Meters will also be bagged. In the event vehicles must be removed from the parade route, please note they will be relocated to the RiverPlex parking lot at 600 NE

Water Street.

Please allow for additional time if you plan to be in the downtown Peoria area and be aware of a significant increase in pedestrian traffic.

Advisory Committee on Police-Community Relations to Host Open House on March 23

The public is invited to an open house with the Advisory Committee on Police-Community Relations on Thursday, March 23 from 6:00 until 7:00 p.m. at ART Inc., 919 NE Jefferson Street. This committee advises the Chief of Police, the Mayor, and the City Council on matters to improve police-community relations. As a committee that provides independent means of communication and assistance between the citizens of Peoria and the Peoria Police Department, engaging with residents is one of the top priorities for this volunteer-run group. This is the first of quarterly meetings the group plans to host for the public.

The open house will include a brief introduction of committee members, followed by the opportunity for public comment and questions and answers if time allows. Committee Chair Shalandra Burch encourages the public to attend, stating, “We want to provide community members with the opportunity to learn more about our group and how we can be a bridge between residents and the Peoria Police Department.”

The [Advisory Committee on Police-Community Relations](#) meets monthly and is comprised of community members, representatives from the NAACP and Peoria Public Schools, and City staff. They currently have three openings.

The city of Peoria will accept applications for the Neighborhood Mini-Grant Program from Monday, March 6th at 8:00 AM through Friday, April 7th at 5:00 PM.

The Neighborhood Mini-Grant Program provides neighborhood and homeowner associations funding for projects that improve neighborhoods and build community. The maximum funding amount per project is \$5,000. Applicants must show proof of community support for their project. Projects must be completed by Friday, December 16th, 2023.

Eligible projects include:

- Security cameras
- Block parties
- Tree-plantings (non-fruit bearing) and landscaping
- Public space improvements such as benches, picnic tables, shelters, or pergolas
- Outreach
- Placemaking
- Public art


