SUBJECT: Issues Update

The following are issues related to the City for the weekly Issues Update. If there are additional items you believe should be included, please let me know.

City Celebrates National Public Safety Telecommunicators Week



National Public Safety Telecommunicators Week (NPSTW) was established in 1982 by the Contra Costa County Sheriff’s Office in California. President Clinton made it official in 1994 when he signed Presidential Proclamation 6667, which declared the second week of April as NPSTW.

The city of Peoria Emergency Communications Center dispatches for 7 law enforcement agencies, including Peoria Police Dept, Peoria County Sheriff’s Office, Peoria Park District, and police departments in Peoria Heights, Chillicothe, Elmwood, and Glasford. They dispatch for 12 fire departments, including Peoria Fire Department, Illinois Air Guard Fire Department, and the fire departments in Akron-Princeville, Brimfield, Chillicothe, Dunlap, Elmwood, Logan-Trivoli, Limestone, Peoria Heights, Timber-Hollis, and West Peoria FD. They also dispatch for 3 EMS agencies: Advanced Medical Transport, Brimfield-Yates City-Elmwood Ambulance, and Akron-Princeville Ambulance. In 2022, they dispatched: 166,396 Law Enforcement calls for service, 30,263 Fire calls for service, and 29,519 Ambulance calls for service. In 2022, dispatchers took 109,881 911 calls and 193,531 non-emergency calls.

Community Development - City Accepting Applications for 2023 Violence Prevention Funding

The City will be accepting applications for 2023 Violence Prevention funding beginning Monday, April 10th at 8:00 AM through May 12th at 2:00 PM. This grant provides funding to non-profits, 501(c)3 organizations, and government agencies to offer violence prevention programs for city of Peoria residents. All programs must be evidence-based and have measurable results.

Programs must fall under one of six priority areas:

- Thriving Neighborhoods
- Empowered Youth & Young Adult
- Restorative & Resilience
- Intervention
- Violence Reduction
- Workforce Training

Workforce Training programs must measure the number of people served and how many clients are connected to permanent employment.

The minimum funding request for Workforce Training is \$150,000 and the maximum funding request is \$300,000. For all other priority areas, funding requests must be between \$50,000 and \$400,000.

How to Apply

Local agencies can apply online and find more information, including program guidelines and a recorded application training session, at the [Violence Prevention Funding Application page](#).

Eligible applications will be reviewed by the Community Development Block Grant (CDBG) Public Services Advisory Commission. Agencies will be notified of funding decisions following City Council approval.

Community Development Pushes for New Bill to Allow Cities to Save Vacant, Abandoned Buildings from Demolition


Last Thursday, April 6th, 2023, Community Development Director Joe Dulin testified before the Illinois House Revenue & Finance Committee in favor of a bill that would increase local control over abandoned, tax delinquent properties. This proposed bill addresses issues in the delinquent property tax process that currently allow abandoned properties with unpaid property taxes to deteriorate beyond repair, draining local resources and attracting blight.

The main goal of this new bill is to save abandoned properties before demolition is necessary. The bill aims to reduce the number of times a property can cycle through the delinquent tax sale process before reverting to public ownership. Current laws allow vacant, tax delinquent properties to sit vacant for far too long and significantly delays the City of Peoria Land Bank from taking action to return the property to productive use.

The City of Peoria is joined by a cohort of cities, think tanks, and non-profit partners seeking a change in the current legislation, including Chicago, Decatur, Kankakee, Rockford, the Center for Community Progress, and the Chicago Community Trust. Director Dulin's remarks were well-received by the Committee and Community Development staff will continue to work with our state legislature to fix Illinois' broken tax buying system.



Peoria Public Library Central Illinois Libraries Partner to Fight Censorship



For the first time, seven Central Illinois libraries and other community organizations have created a special partnership focused on the Freedom to Read, which is essential to our democracy yet under attack via soaring book challenges and bans nationwide.

The American Library Association released new data in March noting that book challenges nationwide not only nearly doubled in 2022 over 2021, but they are the highest they've been since the ALA began compiling data more than 20 years ago.

“Every year for more than 20 years, Peoria Public Library has chosen one book for our community to unite around and read together. This year, we felt it critical to unite around one of our greatest freedoms – our Freedom to Read – and that this be celebrated not just in our city, but across Central Illinois,” said Alyce Jackson, chair of Peoria Public Library’s Peoria Reads Committee and manager of programming at Peoria Public Library. “So, instead of Peoria Reads, this year we are Central Illinois Reads.”

Six area public libraries will join Peoria Public Library along with longtime Peoria Reads partners, Bradley University, Methodist College and Neighborhood House.

Our partner libraries include: Chillicothe Public Library, Dunlap Public Library District, Fondulac District Library, Illinois Prairie District Public Library, Morton Public Library and Peoria Public Library.

“To deny anyone the freedom to read, to dictate that someone else should not have access to a book based on your opinion is to deny them the choice to experience the ideas of others and the opportunity to develop opinions, knowledge, and ideas of their own,” said Fondulac District Library Director Genna Buhr. “Someone can vehemently disagree with a book and still support the freedom to read and access it, as that freedom and opportunity was afforded to them.”

From April through October, culminating in Banned Books Week (Oct. 1-7), Central Illinois Reads will host a number of events to empower everyone to stand against censorship. Hear from nationally known

authors whose books have been banned and from librarians who are pushing back against intolerance, exclusion and censorship.

Oboler Memorial Award, presented annually to a significant published work in the arena of intellectual freedom.




Peoria Cares Communication Transactions During the Month of March 2023








Peoria Cares March 2023 Complaints by Category



Peoria Cares March 2023 Complaints by Department




Peoria Cares Complaint Status "Pending" by Department November 19, 2013 through March 3, 2023






Overall Need Category of Peoria Cares Calls Not Resulting in a Peoria Cares Ticket- March 2023




Service Needs of Peoria Cares Calls Not Resulting in a Peoria Cares Ticket- March 2023
