SUBJECT: Issues Update

City of Peoria Selected for FRA's New Corridor Identification Designation

Designation includes funding for scope, schedule, and cost of passenger rail



On Thursday, December 7, Mayor Ali was joined by former United States Secretary of Transportation Ray LaHood to announce that the city of Peoria was selected for the Federal Railroad Administration's (FRA) Corridor Identification Program. They were joined by representatives from Senator Durbin and Senator Duckworth's offices, elected officials, area leaders, and members from the Peoria Area Passenger Rail leadership team.

The Corridor Identification and Development Program was created under the Bipartisan Infrastructure Law to develop passenger rail routes. Peoria will receive \$500,000 to fund Step 1 of the Service Development Plan, in the Corridor Identification Program. The Service Development Plan will determine engineering and cost requirements. Mayor Ali remarked, “This effort started as a local project that grew into a regional project that became a state project and is now a federal project. This level of support and collaboration will help to achieve our goal of bringing Amtrak passenger rail to and from Peoria in the coming years. I’m very excited about this new development.”

Mayor Ali has been meeting regularly with community leaders and state and local officials since August 2021 on the Peoria Passenger Rail project. The proposed route begins at Peoria and runs through LaSalle-Peru, Utica, Ottawa, Morris, and Joliet, ending at Chicago’s Union Station. “The FRA Corridor Designation for Peoria, plus \$500,000 will continue the momentum to bring passenger rail service to and from Peoria and Chicago,” said former U.S. Secretary of Transportation Ray LaHood. The Peoria Rocket ran for 42 years, carrying travelers from Peoria to Chicago on the Rock Island line with service ending in 1978.

“Illinois is the undisputed transportation hub of North America, with passenger rail at the heart of a vast multimodal system that moves people safely and reliably between our state’s great cities and institutions,” said Illinois Transportation Secretary Omer Osman. “We look forward to working with local stakeholders and continuing to explore the possibilities as efforts to expand passenger service in Illinois advance another step.”

City of Peoria Partners with Ampion Renewable Energy to Provide Savings on Electric Bills

The city of Peoria is partnering with [Ampion Renewable Energy](#) to provide an opportunity to income-eligible community members to sign up for a cost-saving community solar program. Interested individuals can attend one of two open houses scheduled for December 21st and January 9th.

How It Works

This community solar program allows program participants to save money on their electric bills. There is no cost to sign up and participants do not need to purchase or install solar panels.

Program participants are matched to a solar farm. The electricity produced from the solar farm is sent to the grid, increasing the amount of energy available to the community. Ameren Illinois will then apply renewable energy credits to the participant's utility bill each month according to the amount of electricity generated. The renewable energy credits could save customers up to 10% off their electric bill.

Who Is Eligible

Applicants must be city of Peoria residents receiving ongoing public assistance. Applicants will be asked to provide proof of benefits. Please find a list of qualifying benefits below:

- Low Income Home Energy Assistance Program (LIHEAP)
- Supplemental Security Income (SSI)
- Supplemental Nutrition Assistance Program (SNAP)
- Medicaid
- Temporary Assistance for Needy Families (TANF)

Peoria Public Schools is thrilled to introduce the Teacher Ready program, a remarkable opportunity to transform your career! The alternative teacher certification program offers those with a bachelor's degree the opportunity to become a certified teacher through an alternative teacher certification program. Candidates will pay for the Subject Matter Exam, general knowledge exam, and a background check. The remaining cost of this program is 100% covered by Peoria Public Schools upon successful completion. This is a self-paced program based online so there is no deadline to finish and can be completed in less than 12 months. The Teacher Ready program is flexible and designed to be done while still being employed. There is also a tutoring program run by retired teachers to mentor and help students pass their certification exams. Once the program is completed, Peoria Public Schools will award a three-year letter of commitment to teach in our schools.
